



Following the success of our Summer School 2017, we are offering two weeks this year, both weeks will offer our students something a little different.

Musical Theatre Course Information (A)

For ages 4+, classes streamed according to ability.

There will be 5 class per day, commencing at 9am and finishing by approximately 4pm. The course will be delivered by members of Dynamic School of Performing Arts faculty and will comprise of the following:

- Acting for stage
- Singing for stage
- Musical Theatre Workshop
- Dance Workshop
- Tap Workshop
- Show Repertoire – to be released

The Musical Theatre course starts on **Monday 6th August** and ends on **Friday 10th August** with a display of work in our in-house Theatre, to which parents/guardians are invited.

Workshop Summer Intensive Course Information (B)

For ages 7+, classes streamed according to ability.

There will be 4 classes per day commencing at 9am and finishing at 4pm. The course will be delivered from both people in the industry and Dynamic School of Performing Arts Faculty. The week will comprise of:

- Acting to Film and TV
- Producing, devising and directing a film
- Stage Make Up and Special Effects
- Commercial – Terri Johnson
- Ballet – Jo Kirby
- Dance – to be announced
- Audition Prep
- Singing – Emily Partner and Katie Silverson
- Many Many more.....

Workshop Summer School course starts on **Monday 13th August** and ends on **Friday 17th August**.

Cost

The cost of the **Musical Theatre** course is **£130.00**, a **non-refundable** Deposit fee of **£30.00**.

The cost of the **Summer Workshop** course is **£140.00**, a **non-refundable** Deposit of **£40.00**.

Both Courses **£250.00**, a **non-refundable** deposit of **£50.00** to secure place.

Cancellation Charges are as follows:

Up to 6 weeks before – Full refund.

Up to 4 weeks before – 50% refund.

Less than 2 weeks before – no refund.



Terms and Conditions

Payment – Debit and Credit Card Payments

We accept payment from the following:

- Visa, Visa Debit, Electron, Maestro, JCB
- Cash
- Cheques must be cashable before Summer School starts)
- Direct Debit

You will receive a payment receipt and you should keep a copy of this for your records.

Photography/Video Footage

We may take photographs at the Summer School to use for future publicity. To exclude your child we must be informed in writing before your child begins their first day.

Child Protection

Student safety is of the highest priority to all the staff at DSOPA and all those attending the course will be supervised at all times.

All Summer School staff have completed Basic First Aid Training and have been DBS checked.

If there is an emergency and you are unable to collect by 4pm please telephone on (07512 058647) or we are required by Social Services Child Protection to call them.

Staff have a duty to respond if they suspect a child in their care may be suffering from abuse, or if a child makes a disclosure about abuse. In this event they will contact the local Children and Families Team and act on their advice.

Staff Ratio

The Summer School ratio of staff to children is 1:10.

Liability

DSOPA does not accept liability for personal injury or the death of any person unless directly caused by the proven negligence of the company or its servants, in this event our liability insurance provides cover of up to £10 million.

Personal Property

DSOPA will not take responsibility for the loss or damage of any items of personal property brought onto the site.

Mobile phones are not permitted. They will be confiscated and kept in the office until the end of the day.

Appropriate Clothing

DSOPA asks that you don't send your child to Summer School in Heeley's or open toe sandals. They may have to stay inside during break times if they do not have appropriate footwear for running or playing on the school field.



Exclusions

DSOPA reserves the right to exclude any child for any reason at its absolute discretion, including persistent late collection. No refund will be made for days missed and no compensation will be made for any other costs or losses incurred as a result.

Complaints

DSOPA is committed to ensuring every child has a great Summer school and can't wait to come back. If you or your child is not entirely satisfied then we want to be first to know.

If there is a problem while your child is still at the Summer School we can almost always resolve it. If we hear of a problem after a child has left the school we will take great care to look into the matter, but cannot change the situation after the event, so please talk to Megan or Shelley on 07512 058647 or email info@dynamixsopa.co.uk promptly if you have any complaint.

Refunds and compensation will only be made if DSOPA is proven to have been in breach of these terms and conditions, and it is proven further that they were not capable of remedying that breach and as a result the child was withdrawn from the Summer School.

Data Protection

To process your booking, we need to collect personal details about you and the children on your booking. It is your responsibility to ensure that you have permission to pass on these details. We will never pass your details on to any third party.

Admissions

When you accept an offer of a place on Summer School, by paying the tuition fees, you enter into a legally-binding contract with us. This contract requires you to abide by these terms and conditions set out above as well as any of our Rules and Regulations and academic requirements that are relevant to your programme. In the event that the provision of these terms and conditions conflict with the provisions of any other documents forming part of the contract, you shall comply with the provisions of these terms and conditions.

Your acceptance of the offer of a place on the programme will indicate to us that you have sufficient funds to cover the course. As the contracting party, we will hold you liable for your tuition fees and any other fees which you may owe us.
